The President of the International Tribunal for the Law of the Sea,

Having regard to article 27 of the Statute of the Tribunal,

Having regard to articles 45 and 69 of the Rules of the Tribunal,

Having regard to the Order of the President of 28 January 2010 and the Order of the Tribunal of 17 March 2010,

Makes the following Order:

Whereas the President, by his Order dated 28 January 2010, fixed 1 July and 1 December 2010 as the time-limits for the filing, respectively, of the Memorial of Bangladesh and the Counter-Memorial of Myanmar and whereas those pleadings were duly filed within the time-limits prescribed;

Whereas the Tribunal, by its Order dated 17 March 2010, authorized the submission of a Reply by Bangladesh and a Rejoinder by Myanmar and fixed

15 March and 1 July 2011 as the respective time-limits for the filing of them and whereas those pleadings were duly filed within the time-limits prescribed;

THE PRESIDENT

Having ascertained the views of the Parties,

Fixes 8 September 2011 as the date for the opening of the hearing; and

Reserves the subsequent procedure for further decision.

Done in English and in French, both texts being authoritative, in the Free and Hanseatic City of Hamburg, this nineteenth day of August, two thousand and eleven, in three copies, one of which will be placed in the archives of the Tribunal and the others transmitted to the Government of Bangladesh and the Government of Myanmar, respectively.
