SWEARING-IN OF JUDGE JEAN-PIERRE COT

Hamburg, 1 October. Mr. Jean-Pierre Cot (France) was today sworn in as judge of the International Tribunal for the Law of the Sea at a public ceremony presided over by the President of the Tribunal, Judge P. Chandrasekhara Rao.

Judge Cot was elected on 19 April 2002 by the Twelfth Meeting of States Parties to the United Nations Convention on the Law of the Sea to serve a term of nine years, commencing 1 October 2002. Judge Cot has previously served as a judge *ad hoc* at the Tribunal in *The "Grand Prince" Case (Belize* v. *France), Prompt Release.*

In accordance with article 11 of the Statute of the Tribunal, before taking up duties, a newly-elected judge has to make the solemn declaration to exercise the powers as judge impartially and conscientiously. This declaration was made today in the presence of the Tribunal.
